- Documentation supporting your explanation (acceptable documentation may consist of letters, medical records, death certificates, obituaries, birth certificates, official reports, or other information from third party sources which supports the student's case).
- A statement from you explaining what corrective measures you have taken to ensure future eligibility of scholarships.

In some circumstances, appeals may contain information related to sexual harassment, sexual misconduct, and other forms of sex discrimination. According to the University of Missouri System Policy, any incident of sexual harassment of any kind, including sexual assault, committed against students must be reported to the University Title IX Coordinator. Any documentation you provide may be submitted to their office.

DEADLINE FOR SUBMISSION OF THIS FORM: This form must be submitted by the **first Friday** following the start of the fall semester. ****Appeals are reviewed by the UMKC Financial Aid and Scholarships Office. Students are notified in writing via their UMKC email of the decision. This office will reject (deny) any appeal that does not have documentation.**
